WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, PURCHASER ACKNOWLEDGES THAT, EXCEPT AS EXPRESSLY PROVIDED IN THIS QUITCLAIM ASSIGNMENT AND BILL OF SALE, PURCHASER IS ACQUIRING THE TRADEMARK ON AN "AS IS, WHERE IS" BASIS WITHOUT ANY EXPRESS OR IMPLIED WARRANTIES AS TO THE FITNESS FOR A PARTICULAR PURPOSE, MERCHANTABILITY OR CONDITION OF THE TRADEMARK OR AS TO ANY OTHER MATTER.


Without limiting the generality of the foregoing:

- (c) Seller has made no representation, and has specifically disclaimed, that it is the holder of any trademarks that are registered or effective outside the United States.


(d) Purchaser acknowledges that Seller has no obligation to deliver to Purchaser any materials or information relating to the Trademark.
