**RELEASE OF SECURITY INTERESTS IN TRADEMARKS**

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Payoff Letter, NXT hereby releases all liens and security interests granted by Company in favor of NXT pursuant to that certain Trademark Security Agreement, dated as of August 12, 2016, executed by Company in favor of NXT and recorded with the United States Patent and Trademark Office on August 15, 2016 at Reel/Frame 5856/0138 (the "Trademark Security Agreement") and the Collateral Agreement in (i) each Trademark listed on Schedule A attached hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and (ii) all products and proceeds of the forgoing, including without limitation, any claim by Company against third parties for past, present or future (a) infringement or dilution of any such Trademark, or (b) injury to the goodwill associated with any such Trademark.
