**TERMINATION OF SECURITY INTEREST
(Trademarks)**

This **TERMINATION OF SECURITY INTEREST**, dated as of September 22, 2017, is made by **MANUFACTURERS AND TRADERS TRUST COMPANY** (the "Secured Party").

WHEREAS, **CASABELLA HOLDINGS L.L.C.**, a Delaware limited liability company, (the "Grantor"), granted to the Secured Party a security interest in certain property, including without limitation, a security interest in the Trademark Collateral (as defined below) pursuant to that certain Credit Agreement dated as of November 3, 2006, as amended (the "Credit Agreement"), between Grantor and Secured Party;

WHEREAS, a Trademark Security Agreement with respect to the security interest in the Trademark Collateral (as defined below) was recorded with the United States Patent and Trademark Office on November 13, 2006 at Reel 3436/Frame 0863, and a Modification and Reaffirmation of Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 15, 2008 at Reel 3720/Frame 0015; and

WHEREAS, in connection with Grantor's payment in full of its obligations under the Credit Agreement, the Secured Party has agreed to terminate and release its security interest in all such property, including without limitation, the Trademark Collateral (as defined below) as herein provided.

NOW, THEREFORE, for valuable consideration, the Secured Party hereby absolutely, unconditionally and irrevocably terminates and releases all liens and security interests granted to the Secured Party in the following property:

- (i) each trademark, trademark registration, and trademark application listed on Schedule A annexed hereto (such trademarks and trademark applications, the "Trademarks"), together with any renewals or divisions thereof,

and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all proceeds of the foregoing, including without limitation, any claim by any Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark ((i) and (ii) collectively, the "Trademark Collateral").


The Secured Party represents and warrants that it has full authority to execute and deliver this Release, and agrees to reasonably cooperate with the Grantor and to execute and deliver any other instrument required to effect the release of the Secured Party's security interest in the released collateral described herein, at Grantor's cost.

This Termination of Security Interest and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
