**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") is dated as of September 25, 2017 and is made by PROSPECT CAPITAL CORPORATION, a Maryland corporation, acting in its capacity as collateral agent (in such capacity, the "Collateral Agent") under that certain Trademark Security Agreement, dated as of June 18, 2013 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement"), made by Traeger Pellet Grills LLC, a Delaware limited liability company (the "Pledgor"), in favor of the Collateral Agent. Capitalized terms used and not otherwise defined herein have the meanings ascribed thereto in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement, which was recorded in the records of the United States Patent and Trademark Office on June 27, 2013 at reel 5057, frame 0809, the Grantor granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a lien on and continuing security interest in all of the Grantor's right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral, including without limitation the Trademarks set forth on the attached Schedule I; and

WHEREAS, the Grantor has requested, and the Collateral Agent has agreed to provide, a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of the Collateral Agent's lien on and security interest in the Trademark Collateral (the "Released Collateral");


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, without recourse, representation or warranty of any kind whatsoever, terminate and release the liens and security interest created under the Trademark Security Agreement in the Released Collateral.

The Collateral Agent hereby authorizes the Grantor and its agents, representatives and designees to record this Termination and Release of Security Interest in Trademark Collateral with the United States Patent and Trademark Office.


