RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated September 22, 2017 by Canadian Imperial Bank of Commerce, a Canadian chartered bank ("CIBC"), with its mailing address at 199 Bay Street, 4th Floor, Toronto, Ontario, Canada M5L 1A2, acting as administrative agent hereunder for certain Secured Creditors (CIBC acting as such administrative agent being hereinafter referred to as the "Agent");

WITNESSETH:

WHEREAS, FINAL GIFT USA, LLC, a Delaware limited liability company ("Debtor") with its principal place of business and mailing address at 170 Southgate Drive, Guelph, Ontario N1G 4P5 Canada, and Agent were parties to a certain Trademark Collateral Agreement dated August 31, 2016 between Debtor and Agent which was recorded in the United States Patent and Trademark Office on September 1, 2016 at Reel 5876, Frame 0245 as corrected pursuant to that certain Corrective Assignment recorded on September 30, 2016 at Reel 5888, Frame 0228 (collectively, the "Agreement"), pursuant to which Debtor granted to Agent, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "Trademark Property"); and

WHEREAS, Debtor has requested that Agent release its security interests in the Trademark Property and reassign the same to Debtor;

Agent hereby releases its security interests in, and hereby reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Agent, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule A hereto, including:


(i) Each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application and all extensions and renewals thereof; and

(ii) All proceeds of the foregoing, including without limitation (x) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing and (y) any and all claims and causes of action by Debtor against third parties for damages, restitution and injunctive and other legal and equitable relief by reason of past, present or future infringement, dilution, misappropriation, violation, misuse, breach or default of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right but no obligation to sue for and collect, or otherwise recover, said damages.
