## TRADEMARK ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** ("Trademark Assignment"), dated as of April 30, 2017, is made by Knit-Rite, Inc., a Delaware corporation ("Knit-Rite"), in favor of TW Med Management, LLC ("TWMM"), pursuant to the terms and provisions of the Agreement (as defined below). **WHEREAS**, in order to effectuate Knit-Rite's assignment to TWMM of its entire worldwide right, title, and interest in and to the Trademarks, Knit-Rite is executing this Trademark Assignment.


**NOW, THEREFORE**, in view of the good and valuable consideration payable by TWMM to Knit-Rite pursuant to the Agreement, and the mutual promises, covenants, and undertakings set forth herein and therein, the value, receipt, and sufficiency of which are hereby acknowledged, Knit-Rite agrees as follows:

1. Assignment. Knit-Rite hereby transfers and assigns to TWMM all of Knit-Rite's worldwide right, title, and interest in and to the Trademarks, as well as the goodwill of the business associated with the Trademarks, including, without limitation, all rights to police, monitor, and enforce said Trademarks against any and all past, current, and/or future infringements (including, without limitation, the right to sue for and collect damages caused by any such infringement) and any and all further privileges in the United States and throughout the world to establish use, ownership, and/or registration of the Trademarks.
2. Recordation and Further Actions. Knit-Rite hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Trademark Assignment upon request by TWMM.
3. Terms of the Agreement. The terms of the Agreement relating to the Trademarks are incorporated herein by this reference. Such terms shall not be superseded hereby and shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Agreement and the terms hereof, the terms of the Agreement shall govern.
4. Electronic Signatures. Electronically transmitted signatures (e.g., "pdf" signatures attached to an e-mail) shall be deemed originals and shall bind Knit-Rite to this Trademark Assignment.
