RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") is made as of September 22, 2017 ("Effective Date") by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association ("Wells Fargo"), in its capacity as agent for the Lender Group and the Bank Product Providers (in such capacity, together with its successors and assigns in such capacity, "Agent"), in favor of the Grantors identified on Schedule A (collectively, the "Grantors").

Without representation or warranty of any kind or nature, Agent hereby terminates, releases, and discharges its security interest with respect to the Trademark Collateral granted pursuant to the Security Agreement, including, without limitation, its security interest in the Trademarks listed on Schedule A granted pursuant to the Security Agreement, and reassigns to the Grantors all right, title, and interest of Agent in the Trademark Collateral pursuant to the Security Agreement, together with the goodwill associated therewith.
