RELEASE AND DISCHARGE OF SECURITY INTEREST

WHEREAS, Cesca Therapeutics, Inc., a Delaware corporation (the “Company” and “Debtor”) granted a security interest in certain trademarks, trademark applications and registrations, including without limitation, those identified in Exhibit A attached hereto and incorporated herein (the “Collateral”), to Sabby Healthcare Master Fund, Ltd. and Sabby Volatility Warrant Master Fund, Ltd. 
