## ASSIGNMENT OF TRADEMARK RIGHTS

**THIS ASSIGNMENT OF TRADEMARK RIGHTS** (the “Agreement”) is made effective as of the date of the last signature below (the “Effective Date”) by and between ePac, LLC, a Delaware limited liability company, with offices at 8233 Forsythia Street, #116, Middleton, Wisconsin 53562 (“Assignor”), and ePac Holdings, LLC, a Delaware limited liability company, with offices at 8233 Forsythia Street, #116, Middleton, Wisconsin 53562 (“Assignee”).

**WHEREAS**, Assignor desires to assign the EPAC DIGITAL PACKAGING and Design trademark to Assignee and Assignee desires to acquire from Assignor the entire worldwide right, title and interest in and to the EPAC DIGITAL PACKAGING and Design trademark (the “Trademark”).

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee, its entire worldwide right, title, and interest in and to the Trademark, including (a) U.S. Registration No. 5,203,069 (the “Registration”) and Intent to Use Application No. 86/961,483 (the “Application”), (b) all related common law rights in and to the Trademark and the goodwill pertaining thereto worldwide, and (c) all claims, demands and causes of action for the past, present, and future infringement of the Trademark or for unfair competition in business in connection therewith worldwide, the same to be held and enjoyed by Assignee, its successors, assigns or other legal representatives as fully and entirely as the same would or could have been held and enjoyed by Assignor had this assignment not been made. Notwithstanding the

foregoing, the assignment of the Application will only be effective upon the U.S. Patent and Trademark Office's acceptance of the Statement of Use or Allegation of Use for the Application.

Assignor will, without additional consideration, take such further actions and execute promptly such further documents as are necessary or desirable to transfer, vest, record and perfect good, valid and marketable title to the Trademark, including the Application and the Registration, in Assignee. Assignor hereby authorizes Assignee to immediately request that the U.S. Patent and Trademark Office record Assignee as the owner of the Trademark including the Registration, and the Application once the Statement of Use or Allegation of Use for the Application has been accepted by the U.S. Patent and Trademark Office.
