B. **WHEREAS**, as a condition to the consummation the transactions contemplated by the certain Membership Interest Purchase Agreement, dated as of August 11, 2017, by and among Residential Logistics Solutions, LLC, Assignor, Assignee, Robert Peterson, Vasillia Peterson, the Nicole Peterson 2012 Irrevocable Trust and the Brooke Peterson 2012 Irrevocable Trust (the "MIPA"), Assignor is required to contribute all of the Trademarks to Assignee (the "Assignment").

C. **WHEREAS**, Assignee desires to acquire from Assignor and Assignor desires to assign to Assignee the Trademarks; and .


NOW, THEREFORE, Assignor and Assignee, in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, mutually hereby agree as follows:

1. The foregoing Recitals A-C are incorporated herein as though more fully set forth at length, and are made part of this Agreement.
2. Assignor hereby conveys, transfers, and assigns to the Assignee all of the Assignor's right, title, and interest of whatever kind in the mark, together with
 - (a) the goodwill of the business relating to the products and services on which the marks are used and for which they are registered,
 - (b) all income, royalties, and damages hereafter due or payable to Assignor with respect to the marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the marks, and
 - (c) all rights to sue for past, present and future infringement or misappropriations of the marks.


3. The Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the mark and its related property.
