TO HAVE AND TO HOLD the aforementioned properties, assets and rights unto Tapas IP, its successors and assigns, to and for its use forever.

Global Tapas shall promptly, upon the request of Tapas IP and/or its successors and assigns, execute such other documents and/or instruments of assignment, transfer and conveyance as Tapas IP and/or its successors and assigns may reasonably request to permit the recordation of the assignment made by this instrument or of any other documents Tapas IP or any of its successors or assigns may reasonably deem necessary or advisable to effectuate the terms and intent of this Assignment. Without limiting the foregoing, Global Tapas hereby irrevocably appoints Tapas IP and each of Tapas IP's officers and/or directors, successors and assigns, signing singly as attorney-in-fact with full power (and coupled with an interest), with full power of substitution, to be Global Tapas' true and lawful attorney, in Global Tapas' name, place and stead, to execute, acknowledge, swear to and file all documents (including but not limited to any instrument of assignment, transfer and/or conveyance) and to take all actions which Tapas IP or such other person deems necessary, appropriate or desirable to effectuate the intent of this Assignment.
