INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of September 28, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified or replaced from time to time, this "IP Security Agreement"), is made by OSTERHOUT GROUP, INC. (the "Grantor") in favor of 21ST CENTURY FOX AMERICA, INC. (together with its successors in interest, the "Lender").

WHEREAS, Grantor and Lender have entered into a Loan and Guarantee and Security Agreement, dated as of September 28, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified or replaced from time to time, the "Loan Agreement"). Capitalized terms used and not defined herein have the meanings set forth in the Credit Agreement;

WHEREAS, under the terms of the Loan Agreement and subject to the limitations contained therein, Grantor has (i) granted to the Lender a security interest in all of Grantor's right, title and interest in, to and under the Collateral, which Collateral includes General Intangibles, including intellectual property, whether now or hereafter acquired or arising, and all proceeds and products thereof, and (ii) agreed to execute any further agreements and instruments as may be reasonably requested by Lender to perfect, protect or continue the Lender's Lien in the Collateral; and

WHEREAS, pursuant to Lender's reasonable request, Grantor agrees to execute this IP Security Agreement with respect to its Patents, Trademarks, Copyrights, Computer Software, Trade Secrets and IP Agreements (as hereinafter defined and, collectively, the "IP Collateral") in order to record the security interests granted therein with the United States Copyright Office or United States Patent and Trademark Office, as applicable (or any successor office or other applicable government registry in any jurisdiction).

NOW, THEREFORE, in consideration of the above premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor hereby agrees as follows:

SECTION 1 Grant of Security. Grantor hereby grants to Lender for Lender's benefit, as collateral security for the full and punctual payment of the Obligations when due (whether at the stated maturity, by acceleration or otherwise), a security interest in all of Grantor's right, title and interest in and to the following:

(a) all patents, patent applications, utility models, statutory invention registrations and all inventions, including those claimed or disclosed therein and all improvements thereto ("Patents");

(b) all trademarks, trademark applications, service marks, domain names, trade dress, logos, designs, slogans, trade names, business names, corporate names and other source identifiers, and all general intangibles of like nature whether registered or unregistered (but excluding in all cases all intent-to-use United States trademark applications for which an amendment to allege use or statement of use has not been filed under 15 U.S.C. § 1051(c) or 15

U.S.C. § 1051(d), respectively, or if filed, has not been deemed in conformance with 15 U.S.C. § 1051(a) or examined and accepted, respectively, by the United States Patent and Trademark Office, provided that upon such filing and acceptance, such intent-to-use applications shall be included in the definition of Trademarks), together, in each case, with the goodwill symbolized thereby ("Trademarks");

(c) all copyrights, including, without limitation, copyrights in Computer Software (as hereinafter defined), internet web sites and the content thereof, whether registered or unregistered ("Copyrights");

(d) all computer software, programs and databases (including, without limitation, source code, object code and all related applications and data files), firmware and documentation and materials relating thereto, together with any and all maintenance rights, service rights, programming rights, hosting rights, test rights, improvement rights, renewal rights and indemnification rights and any substitutions, replacements, improvements, error corrections, updates and new versions of any of the foregoing ("Computer Software");

(e) all confidential and proprietary information, including, without limitation, know-how, trade secrets, manufacturing and production processes and techniques, inventions, research and development information, databases and data, including, without limitation, technical data, financial, marketing and business data, pricing and cost information, business and marketing plans and customer and supplier lists and information (collectively, "Trade Secrets"), and all other intellectual and intangible property of any type, including, without limitation, industrial designs and mask works;

(f) all registrations of, applications for registration for, or recordals of any of the foregoing in the United States Patent and Trademark Office, the United States Copyright Office, or foreign equivalents, as applicable, including, without limitation, the registrations and applications for registration of United States intellectual property set forth in Schedule I hereto (as may be supplemented from time to time), together with all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations thereof;

(g) all written agreements, permits, consents, orders and franchises relating to the license, development, use or disclosure of any of the foregoing to which Grantor, now or hereafter, is a party or a beneficiary ("IP Agreements") and all rights of Grantor thereunder, including all income, royalties and other payments now and hereafter due and/or payable; and

(h) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages.

SECTION 2 Recordation. Grantor hereby authorizes and requests that the Register of Copyrights and Commissioner of Patents and Trademarks, as applicable, and any other applicable United States or foreign government officer record this IP Security Agreement.

SECTION 3 Execution in Counterparts. This IP Security Agreement may be executed in any number of counterparts (including by telecopy or other electronic transmission), each of

which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 4 GOVERNING LAW. THIS IP SECURITY AGREEMENT AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS IP SECURITY AGREEMENT AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.

SECTION 5 Conflict Provision. This IP Security Agreement has been entered into in conjunction with the provisions of the Loan Agreement. The rights and remedies of each party hereto with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Loan Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this IP Security Agreement are in conflict with the Loan Agreement, the provisions of the Loan Agreement, as applicable, shall govern.

SECTION 6 Counterparts. This IP Security Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which taken together shall constitute one single agreement between the parties. Electronically transmitted signatures shall have the full force and effect of an original signature.

SECTION 8 Notice. Each party to this IP Security Agreement irrevocably consents to service of process in the manner provided for notices in Section 11 of the Loan Agreement and as further provided in Section 12 of the Loan Agreement.

SECTION 9 Severability. Whenever possible, each provision of this IP Security Agreement shall be interpreted in such manner as to be valid and effective under applicable law, but if any provision of this IP Security Agreement or the application of any such provision to any person or circumstances shall be held invalid, illegal or unenforceable in any respect by a court of competent jurisdiction, such invalidity, illegality or unenforceability shall not affect any other provision hereof.
