The terms and conditions of the aforementioned security interest are contained in that certain Second Amended and Restated Loan and Security Agreement dated as of April 30, 2016, by and between, among others, certain Debtors and Secured Party, and other loan documents, (collectively, the “**Agreements**”), as security for the Obligations as set forth in the Agreements and other agreements referred to therein. Nothing contained in this Memorandum and Notice of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which Secured Party may have in any other collateral described in the Agreements or otherwise.


