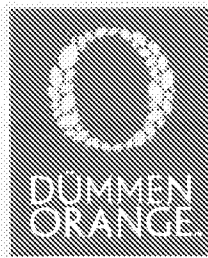

**DEED OF TRANSFER INTELLECTUAL PROPERTY RIGHTS**  
**("DEED OF TRANSFER")**

**THIS DEED OF TRANSFER IS MADE BETWEEN:**

**PARTIES:**

- I. **DÜMMEN ORANGE HOLDING B.V.**, a private company with limited liability, incorporated under the laws of The Netherlands, with registered seat in De Lier, The Netherlands, registered with the Dutch trade register under number 57754950 ("**Assignor**"); and
- II. **DÜMMEN GROUP B.V.**, a private company with limited liability, incorporated under the laws of The Netherlands, with registered seat in De Lier, The Netherlands, registered with the Dutch trade register under number 57757496 ("**Assignee**").

collectively referred to as the "**Parties**", and each individually a "**Party**".

**RECITALS:**

- A. Assignee is currently ultimately 100% owned by Assignor, which is a holding company incorporated in the Netherlands.
- B. By the virtue this Deed of Assignment, the Parties hereby agree to the sale, assignment and transfer of Intellectual Property Rights ("**IPR**"), including the Trademarks along with all of the accompanying goodwill as listed in Annex A, Plant Breeders' Rights ("**PBR**") as listed in Annex B and Utility Patents as listed in Annex C in accordance with the terms and conditions set out in this Deed of Transfer.

**IT IS HEREBY AGREED AS FOLLOWS:**

**1. RIGHTS ASSIGNMENT AND TRANSFER**

- 1.1. Assignor sells, assigns and transfers to Assignee, and Assignee purchases and accepts the assignment and transfer from Assignor of all rights, title and interest in the IPR, with effective date as of 19 May 2017 ("**Effective Date**"). The related secret technical or business know-how and the related functions shall be transferred to Assignee together with IPR in a "package deal". The trademarks shall be transferred along with all accompanying goodwill.
- 1.2. The Parties agree that this Deed of Transfer shall function as an instrument of delivery of all rights, title and interest in the IPR to Assignee as per the Effective Date.



- 1.3. The Assignor and Assignee agree on a purchase price for the sale, assignment and transfer of the IPR from Assignor to Assignee of USD 2,000,000 (2 million) ("**Purchase Price**").
- 1.4. The Purchase Price is determined considering the future profitability of the business. The Parties shall document how the Purchase Price was determined in a transfer pricing documentation.

## **2. REGISTRATION**

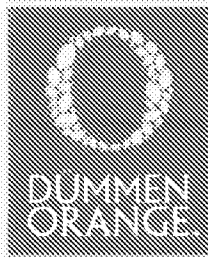
- 2.1. Assignee shall have the right to register the assignment and transfer of the IPR in the relevant register held by the Community Plant Variety Office, the European Union Intellectual Property Office, the Benelux Office for Intellectual Property, the United States Patents and Trademark Office or any other relevant national or international Intellectual Property Office worldwide. Unless otherwise agreed between the Parties, any costs associated with such registration will be for the account of and shall be paid by Assignee.
- 2.2. Assignor shall provide Assignee with all necessary cooperation for the registration after the date of this Deed of Transfer. Assignor hereby grants an irrevocable power of attorney to Assignee to sign any additional documents and to undertake any other acts that may be necessary in order to complete the assignment and transfer of the IPR referred to in article 1.1 and the recordal thereof in the register as referred to in article 2.1.

## **3. GOVERNING LAW AND JURISDICTION**

### **3.1. Applicable law and forum**

- 3.1.1. This Deed of Transfer and the transactions contemplated herein shall be governed by and construed in accordance with the laws of the Netherlands.
- 3.1.2. All disputes arising from or in connection with this Deed of Transfer and the transactions contemplated herein shall be exclusively submitted to the competent court in The Hague, The Netherlands.
