(iii) Assignor has not licensed, sold, conveyed or assigned away the Granted Rights under this Assignment and will not take any other action in derogation of Assignee's rights under this Assignment.

(B) Assignee hereby represents and warrants that:

(i) it has the full right, power and authority to enter this Assignment and to perform and fulfill all of the obligations to be rendered and satisfied by it hereunder, and that there are no claims, facts or circumstances existing or pending which would prevent its full performance of its obligations hereunder.


