**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST  
IN TRADEMARKS**

**THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS** (this "Termination"), is dated as of April 5, 2017, and made by **TAG FINANCING, LLC**, a Delaware limited liability company, located at 301 Commerce Street, #3300, Ft. Worth, TX 76102 ("Grantee"), in favor of **CIVIGENICS, INC.**, a Massachusetts corporation ("Civigenics") and **COMMUNITY EDUCATION CENTERS, INC.**, a Delaware corporation ("CEC") and together with Civigenics, the "Grantors").

**WHEREAS**, pursuant to that certain Trademark Security Agreement dated as of December 13, 2010, made by the Grantors in favor of Grantee (the "Security Agreement"), a security interest was granted by each Grantor to Grantee in certain collateral, including the Trademark Collateral (as defined in the Security Agreement); and

**WHEREAS**, Grantee now desires to terminate and release the Security Agreement.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Grantee hereby states as follows:

1. Definitions. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement.

2. Termination and Release. Grantee hereby:

a. absolutely, unconditionally and irrevocably terminates the Security Agreement, and any other agreement under which the Grantors have granted a collateral mortgage, pledge, hypothecation, grant, assignment, lien, or security interest in, to, or under the Trademark Collateral;

b. absolutely, unconditionally and irrevocably terminates, cancels, forever discharges, and releases the mortgage, pledge, hypothecation and lien on, and security interest in and to, the right, title, and interest in, to, and under the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;

c. represents and warrants that it has full authority to execute and deliver this Termination; and


d. authorizes the recordation of this Release with the United States Patent and Trademark Office.

3. Further Assurances. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect, confirm or reflect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to the Trademark Collateral, Grantee will execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.
