**RELEASE AND REASSIGNMENT OF
TRADEMARKS AND TRADEMARK APPLICATIONS**

September 28, 2017

Reference is hereby made to that certain Trademark Security Agreement (the "Agreement"), dated as of August 12, 2008, executed by Accela, Inc., a California corporation ("Grantor"), whose address is 2633 Camino Ramon, Suite 500, Bishop Ranch 3, San Ramon, California 94583, in favor of Wells Fargo Foothill, LLC a Delaware limited liability company now known as Wells Fargo Capital Finance, LLC, a Delaware limited liability company, as Agent ("WFCF"), whose address is 2450 Colorado Avenue, Suite 3000 West, Santa Monica, California 90404, which was recorded in the United States Patent and Trademark Office ("USPTO") on August 14, 2008, at Reel 3835 Frame 0898, as amended by that certain Amendment to Trademark Security Agreement, dated September 4, 2015, which was recorded in the USPTO on September 9, 2015, at Reel 5618 Frame 0992, and pursuant to which the Grantor assigned and granted to WFCF a security interest in the Trademark Collateral, as defined in the Agreement, and that certain Security Agreement, dated as of August 12, 2008 (as amended, restated, supplemented or otherwise modified from time to time the "Security Agreement"), among the Grantor, the other parties thereto and WFCF, including those trademarks specifically listed on Schedule I attached hereto; and


WHEREAS, WFCF wishes to terminate the Agreement, release its lien on and security interest in the Trademark Collateral and retransfer and reassign to Grantor without representation or warranty, all of WFCF's right, title and interest in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, WFCF hereby terminates the Agreement and hereby terminates and releases its security interest in the Trademark Collateral arising under the Agreement and the Security Agreement, releases, retransfers and reassigns to Grantor without representation or warranty, any and all liens, security interests, right, title and interest of WFCF in and to the Trademark Collateral.
