**DECLARATION WITH REQUEST FOR CORRECTIVE ASSIGNMENT**

On November 15, 2016, I, Russell E. Fowler II, submitted requests for recordation of name changes in association with each of the above-referenced U.S. Trademark Registrations (collectively, the "True Home Registrations") (with resubmissions also made on December 9, 2016). These requests included (1) a name change from "Defender Security Company" to "Defenders Inc." and then (2) a name change from "Defenders Inc." to "Defenders, Inc." The name change from "Defender Security Company" to "Defenders Inc." was recorded at Reel/Frame 5920/0523 for each of the True Home Registrations. The name change from "Defenders Inc." to "Defenders, Inc." was recorded at Reel/Frame 5954/0828 for each of the True Home Registrations. However, the recording of the name changes at Reel/Frame 5920/0523 and Reel/Frame 5954/0828 were improper because neither Defenders Inc. nor Defenders, Inc. owned the True Home Registrations at the time of the name change (i.e., as of June 22, 2015). Instead, the correct owner of the True Home Registrations at the time of the name change (i.e., as of June 22, 2015) was another owner (i.e., WCA Group, LLC) who subsequently assigned the entire interest in the True Home Registrations to True Homes, LLC.

The current owner of the True Home Registrations is True Homes, LLC. The documents recorded in association with the True Home Registrations at Reel/Frame 5920/0523 and Reel/Frame 5954/0828 were erroneous for the reasons provided above. The last correct owner of the True Home registration has been and continues to be True Homes, LLC. The fee for this corrective assignment is also being submitted herewith.




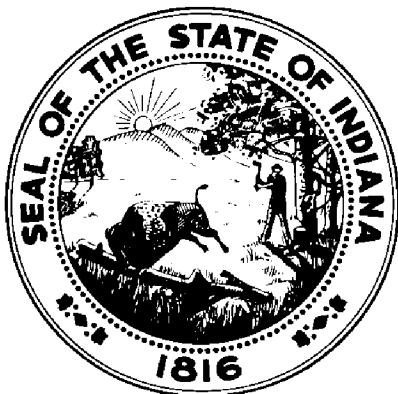
