**RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARKS** (this “Release”), dated as of September 29, 2017 (the “Effective Date”), is made by JPMorgan Chase Bank, N.A., in its capacity as administrative agent pursuant to the Credit Agreement (as defined below) (in such capacity, the “Agent”) for the Secured Parties, in favor of Conduent Business Services, LLC (the “Grantor”).

**WHEREAS**, the Grantor, the Agent and the other parties thereto entered into that certain Credit Agreement, dated as of December 7, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”);

**WHEREAS**, the Grantor, the Agent and the other parties thereto entered into that certain Security Agreement, dated as of December 7, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

**WHEREAS**, pursuant to the Security Agreement, the Grantor pledged, collaterally assigned, mortgaged, transferred and granted to the Agent, on behalf of and for the benefit of the Secured Parties, a continuing security interest in all of the Grantor’s right, title or interest in, to or under the trademarks set forth in Schedule I hereto (“Trademark Collateral”);

**WHEREAS**, pursuant to the Security Agreement, the Grantor executed and delivered a Trademark Security Agreement, dated as of May 4, 2017 (the “Trademark Security Agreement”), for recordation with the United States Patent and Trademark Office;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 8, 2017 at Reel/Frame 6052/0790; and

**WHEREAS**, pursuant to that certain Confirmation of Release of Liens, dated as of September 29, 2017, entered into by the Agent, as Administrative Agent and as Collateral Agent, the Grantor and certain other parties thereto, the Agent has agreed to release the security interest granted to the Agent in and to the Trademark Collateral.

**NOW, THEREFORE**, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. **Defined Terms.** All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.


2. **Release and Termination.** The Agent, without representation or warranty of any kind, on behalf of the Secured Parties, hereby terminates, cancels, releases and forever discharges the security interest in the Trademark Collateral, and retransfers and reassigns to the Grantor any right, title or interest the Agent may have in, to or under the Trademark Collateral. For clarity, the Agent is only terminating, releasing and discharging its security interest in the trademarks set forth in Schedule I hereto, and all other security interests granted to the Agent with respect to all other collateral pursuant to the Security Agreement and the Trademark Security Agreement shall continue in full force and effect, and the Agent’s security interest, liens, rights, titles and interests in such other collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Release.

3. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
