RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL

This RELEASE, dated as of September 29, 2017, is made by MARANON CAPITAL, L.P., as Agent (the "Agent") under that certain Amended and Restated Credit Agreement, dated as of May 26, 2015 (the "Credit Agreement"), and that certain Security Agreement dated as of December 4, 2012 (the "Security Agreement").

WHEREAS, Ameda, Inc., a Delaware corporation (the "Grantor") and the Agent are parties to that Trademark Security Agreement dated as of October 11, 2016 (the "Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement and recorded with the U.S. Patent and Trademark Office on November 7, 2016 at Reel/Frame No. 5915/0013, the Grantor granted to the Agent a first priority security interest in all of its right, title and interest in, to and under its Trademark Collateral (as defined in the Security Agreement).

WHEREAS, the Grantor has requested that the Agent terminate and release its security interest in all of its right, title and interest in and to its Trademark Collateral, including those trademark registrations and applications set forth in Schedule I.

NOW, THEREFORE, the Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse its security interest on all of its right, title and interest in and to the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I, attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral are hereby discharged, terminated and released and hereby transfers and assigns to the Grantors any and all right, title and interest that the Agent may have obtained in, to and under the Trademark Collateral under the Trademark Security Agreement.

The Agent agrees to provide the Grantor with any information and additional authorization reasonably necessary to effect the release of the Agent's security interest in the Trademark Collateral.
