**FIRST LIEN TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This First Lien Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of October 3, 2017, by **SUNTRUST BANK**, a Georgia corporation (the “Collateral Agent”) in favor of **DATABANK HOLDINGS LTD.**, a Texas limited partnership with an address at 400 South Akard Street, Suite 100, Dallas, Texas 75202 and **ARSALON TECHNOLOGIES, LLC**, a Kansas limited liability company with an address at 10605 W. 84th Terrace, Lenexa, Kansas 66214 (collectively, the “Pledgors”).

WITNESSETH:

WHEREAS, the Pledgors entered into a certain first lien trademark security agreement dated July 13, 2016 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on July 13, 2016 at the United States Patent and Trademark Office at Reel 5834, Frame 0278 and Reel 5834, Frame 0252.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Pledgors granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of their Trademark Collateral, including the Trademarks listed in **Schedule A**.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby agrees as follows:

1. The Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Pledgors, including all goodwill associated with the Trademark Collateral, and assigns, transfers and conveys to Pledgors any interest in such intellectual property, including the Security Interest.


2. The Collateral Agent authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Trademark Release.

3. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
