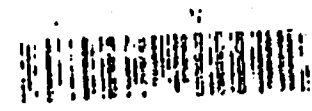

5. Certificate of Formation of the Converted Entity. The Certificate of Formation of the Converted Entity is attached to this Certificate of Conversion as Exhibit A.
6. Approval of the Plan of Conversion. The Plan of Conversion has been approved as required by the laws of the State of Texas and the governing documents of the Converting Entity.
7. Effectiveness of Filing. This Certificate of Conversion becomes effective upon filing with the Secretary of State of the State of Texas.
8. Assumption of Fees and Franchise Tax Liability. The Converted Entity will be responsible for all fees and franchise taxes applicable to the Converting Entity, and the Converted Entity will be obligated to pay all such fees and franchise taxes if such fees and franchise taxes are not timely paid.
