TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made this 4th day of October, 2017 (the "Release Date") by Wells Fargo Bank, National Association (successor in interest to Wachovia Bank, National Association, successor in interest to Congress Financial Corporation (Central)), a North Carolina National Bank Association, ("Wells Fargo") for the benefit of Gregg Appliances, Inc., an Indiana corporation ("Gregg").

WHEREAS, pursuant to that certain Trademark Collateral and Security Agreement dated February 3, 2005, made by Gregg in favor of Congress Financial Corporation (Central) ("Congress"), recorded on March 23, 2005 with the United States Patent and Trademark Office (the "USPTO") at Reel 003138, Frame 0741, Gregg granted a security interest in certain trademarks (collectively, the "Congress Trademarks") in favor of Congress to secure certain debt owing from Gregg to Congress (the "Congress Security Agreement");

WHEREAS, as stated in the preamble of this Release, Wells Fargo is successor in interest to Wachovia Bank, National Association, which is successor in interest to Congress;

WHEREAS, pursuant to that certain Trademark Security Agreement dated July 25, 2007, made by Gregg in favor of Wachovia Bank, National Bank Association, as Administrative Agent, ("Wachovia"), recorded on September 1, 2001 with the USPTO at Reel 003613, Frame 0135, Gregg granted a security interest in certain trademarks (collectively, the "Wachovia Trademarks") in favor of Wachovia to secure certain debt owing from Gregg to Wachovia (the "Wachovia Security Agreement");

WHEREAS, as stated in the preamble of this Release, Wells Fargo is successor in interest to Wachovia;

WHEREAS, pursuant to that certain Amendment No. 1 to Trademark Collateral and Security Agreement dated March 29, 2011, made by Gregg in favor of Wells Fargo, recorded on April 15, 2015 with the USPTO at Reel 004523, Frame 0609, Gregg granted a security interest in certain trademarks (collectively, the "Wells Fargo 2011 Trademarks") in favor of Wells Fargo to secure certain debt owing from Gregg to Wells Fargo (the "Wells Fargo 2011 Security Agreement");

WHEREAS, pursuant to that certain Trademark Security Agreement dated June 28, 2016, made by Gregg in favor of Wells Fargo, recorded on February 3, 2017 with the USPTO at Reel 005993, Frame 0522, Gregg granted a security interest in certain trademarks (collectively, the "Wells Fargo 2016 Trademarks", and together with the Wells Fargo 2011 Trademarks, the Wachovia Trademarks, and the Congress Trademarks, the "Trademarks") in favor of Wells Fargo to secure certain debt owing from Gregg to Wells Fargo (the "Wells Fargo 2016 Security Agreement" and together with the Wells Fargo 2011 Security Agreement, the Wachovia Security Agreement, and the Congress Security Agreement, the "Security Agreements");

WHEREAS, Gregg has requested that Wells Fargo (i) terminate and release the liens and interests of Wells Fargo in Gregg's Trademarks as set forth in Exhibit A attached hereto, and (ii)

execute and deliver evidence of such termination and release for filing in the USPTO and other appropriate offices;

WHEREAS, all outstanding amounts owed under any financing documents executed in connection with the Security Agreements have been satisfied and Gregg has requested that Wells Fargo release their security interest in the Trademarks; and

WHEREAS, Wells Fargo has agreed to such release and termination.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Wells Fargo agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, Wells Fargo hereby irrevocably and forever terminates, releases and discharges any and all security interests in the Trademarks granted by Gregg under the Security Agreement, together in each case with the goodwill of the business connected with the use of, and symbolized by, each such Trademark.

2. Recordation of Release. Wells Fargo understands and agrees that this Release may be recorded by or for Gregg with the USPTO.
