DECLARATION FOR CORRECTION OF OWNERSHIP

I, Ryan Christensen, declare as follows:

1. I am legal counsel for Airbus DS Communications, Inc., a California corporation located at 42505 Rio Nedo, Temecula, California 92589 ("Airbus"). Airbus is the current owner of United States Registration No. 2177063 for the trademark PALLADIUM (the "Registration").
2. I am submitting this declaration for the purpose of correcting the chain of title in the records of the U.S. Patent and Trademark Office (the "USPTO") with respect to the Registration.
3. On January 25, 2008, Intrado, Inc., the then owner of the Registration, assigned its entire interest in the Registration to Tel Control, Inc. This assignment was recorded with the USPTO at Reel/Frame 3704/0047.
4. On April 14, 2009, Tel Control, Inc. assigned its entire interest in the Registration to Plant Equipment Inc. This assignment was recorded with the USPTO at Reel/Frame 3970/0601.
5. On August 12, 2009, subsequent to the assignments described in Paragraphs 3 and 4 above, Wachovia Bank recorded a Security Agreement against the Registration, effective as of August 10, 2009, which was recorded with the USPTO at Reel/Frame 4042/0725 (the "Wachovia Security Agreement"). One of the borrowers identified in the Wachovia Security Agreement was Intrado, Inc. Plant Equipment Inc., which was the owner of the Registration on August 10, 2009 and August 12, 2009, was not a party to the Wachovia Security Agreement and did not grant a security interest in the Registration to Wachovia Bank.

6. Because all rights in the Registration had been assigned by Intrado, Inc. to Tel Control, Inc. on January 25, 2008, and Tel Control, Inc. subsequently assigned all rights in the Registration to Plant Equipment Inc. on April 14, 2009, Intrado, Inc. was no longer the owner of the Registration at the time it granted a security interest to Wachovia Bank and had no right to grant a security interest in the Registration to Wachovia Bank. I believe the Registration was inadvertently and mistakenly included in the Wachovia Security Agreement based on a mistaken belief that Intrado, Inc. still owned the Registration in August of 2009.

7. Based on the foregoing, I respectfully request that the USPTO correct the chain of title with respect to the Registration to remove recordation of the Wachovia Security Agreement against the Registration.

8. Prior to my recording this document with the USPTO, I provided a copy of this Declaration to Cahill Gordon & Reindel, LLP, the law firm representing Wachovia in the 2009 transaction that assisted with the recording of the Wachovia Security Agreement on behalf of Wachovia Bank in 2009.

9. I hereby declare that all statements made herein of my own knowledge are true and correct.

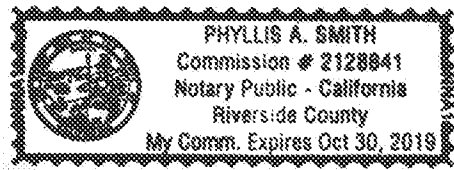
