INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (the "Assignment"), is entered into as of August 23, 2017, by and between Dashed, Inc., a Massachusetts corporation ("Assignor"), and Foodler Acquisition LLC, a Delaware limited liability company ("Buyer"). Capitalized terms used herein and not otherwise defined shall have the meanings ascribed to such terms in the Agreement (as defined below).

WHEREAS, Assignor, Buyer and certain other Persons are parties to that certain Asset Purchase Agreement, dated as of June 8, 2017, as amended by that certain Amendment to Asset Purchase Agreement, dated as of August 21, 2017 (as amended, the "Agreement"); and

WHEREAS, pursuant to the Agreement, Assignor wishes to assign to Buyer, and Buyer wishes to acquire from Assignor all right, title and interest in any Seller Proprietary Rights (as defined in the Purchase Agreement) of Assignor, including all registrations and applications for Proprietary Rights set forth on Schedule I attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound hereby, agree as follows:

ARTICLE I ASSIGNMENT

Section 1.1 Assignment of Intellectual Property Assets. Assignor hereby transfers, conveys, assigns and delivers to the Buyer, and Buyer hereby accepts, as applicable, from Assignor, all of Assignor's right, title and interest in and to (a) all trademark registrations and applications and all goodwill associated therewith; (b) all pending patent applications and registered patents; (c) all copyright registrations; and (d) all Internet domain name registrations in each case as set forth on Schedule I hereto (as may be supplemented or updated from time to time after the date hereof by the parties hereto), including, in each case, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for Buyer's own use and enjoyment, and for the use and enjoyment of Buyer's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with the exclusive rights to (i) bring actions, defend against or otherwise recover for infringements or other impairments of such Proprietary Rights, and the right to the profits or damages due or accrued, arising out of or in connection with any and all past, present or future infringements or other impairments of such Proprietary Rights, (ii) apply for, make filings with respect to and maintain all registrations, renewals and extensions thereof, and (iii) any other rights of any kind whatsoever of Assignor accruing thereunder.

Section 1.2 Assignor hereby requests the Commissioner of Patents and Trademarks and the Register of Copyrights of the United States, and the corresponding entities or agencies in any applicable foreign countries, to record the Buyer as the assignee and owner of the Proprietary Rights set forth on Schedule I.

Section 1.3 Assignor represents and warrants that: (a) it is the sole and exclusive owner of the entire right, title and interest in and to the Proprietary Rights (including the corresponding rights set forth in the above), free and clear of any liens, security interests or other encumbrances; (b) it has the full right and authority to execute this Assignment and to assign to Buyer the rights assigned herein; and (c) it has not executed, and will not execute, any agreement or other instrument in conflict herewith.

ARTICLE II ADMINISTRATION


Section 2.1 Further Assurances. Assignor shall take all further actions, and provide to Buyer, Buyer's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation), requested by Buyer to more fully and effectively effectuate the purposes of this Assignment, including, without limitation, with respect to the following: (a) the preparation and prosecution of any application for registration, or any application for renewal of a registration, relating to any of the rights assigned herein; (b) the prosecution or defense of any interference, opposition, infringement or other proceedings that may arise in connection with any of the rights assigned herein; (c) obtaining any additional protection relating to rights assigned herein that Buyer reasonably may deem appropriate that may be secured under the laws now or hereafter in effect in the United States or in any foreign country; and (d) in the implementation or perfection of this Assignment in all applicable jurisdictions throughout the world.

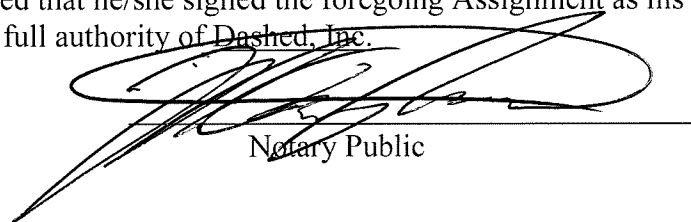

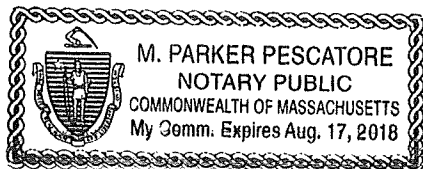

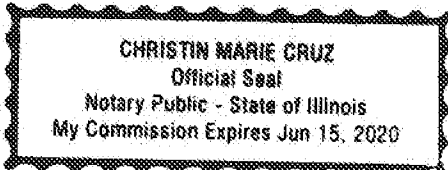

1. Trademark for “DASHED”, U.S. Serial Number 86700128 and U.S. Registration Number 4904973 with a registration date of February 23, 2016.
2. Domain name “dashed.com”, registered in the name of Philip Dumontet.
3. Dashed logo (the intersecting orange triangles)



4. Software modules including Dashed driver iOS app, Dashed driver Android app. The Dashed Driver app enables contracted Dashed drivers to accept and complete Dashed delivery orders. Each driver is provided with a unique driver user name and 4 digit password to sign on. New order notifications appear on the app, and the driver can choose to accept or decline the job. The app provides pickup information to the driver (order number, restaurant location, order contents), as well as customer delivery information, so that the deliveries can be completed. Quick access to Zello, a walkie talkie system between the driver and the dispatch office, is provided. The driver can choose which map platform he/she prefers for routing to the restaurant or customer: Apple Maps, Google Maps, or Waze. The app also allows the driver to see number of deliveries made in the previous 2 weeks, and their current driver rating.
