RELEASE OF TRADEMARK SECURITY INTERESTS

- B. WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame 005495/0691 on April 10, 2015;
- C. WHEREAS, Bank hereby confirms that the security interest in the Grantor's intellectual property has been discharged, terminated and released in all respects.

AGREEMENT

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby (1) terminates, releases and discharges any and all security interests that it has pursuant to the Intellectual Property Security Agreement in any and all right, title and interest of the Grantor, and (2) reassigns to the Grantor any and all right, title and interest that it may have had in the Grantor's intellectual property. Bank specifically acknowledges that the Security Agreement is no longer effective as to the Grantor's Trademarks on Schedule A hereto, and that Bank does not own any rights to or have any ownership interest or claim in any of the Grantor's Trademarks on Schedule A.

Bank acknowledges and confirms that the terms and conditions of this Release of Security Interest shall be effective evidence of the release of the security interests in the Grantor's Intellectual Property, whether or not this Release is recorded with the U.S. Trademark and Patent Office or otherwise.
