**RELEASE OF TRADEMARK SECURITY INTEREST**

This Release of Trademark Security Interest ("Release") is dated effective October 3, 2017 by ANCHOR BANK, NATIONAL ASSOCIATION, a national banking association (the "Secured Party"), to THE SIERRA COMPANY LLC, a Minnesota limited liability company formerly known as The Sierra Corporation, a Minnesota corporation (the "Debtor"), as follows:

WHEREAS, Debtor and the Secured Party are parties to that certain Pledge and Security Agreement dated April 30, 2015 and that certain Confirmatory Grant of Security Interest in Intellectual Property dated April 30, 2015 (collectively, the "Security Agreement");

WHEREAS, pursuant to said Security Agreement, Debtor granted to the Secured Party, among other collateral, a continuing security interest in all of the Debtor's right, title and interest, including goodwill, in, to and under its United States trademarks listed on the attached Schedule A (the "Trademarks");

WHEREAS, evidence of the Security Agreement was recorded in the United States Patent and Trademark Office on May 4, 2015, at reel/frame 5509/0446; and

WHEREAS, the Secured Party wishes to release its security interest in the Trademarks listed on Schedule A only and retransfer and reassign to the Debtor without recourse all of the Secured Party's right, title and interest in and to the Trademarks listed on Schedule A.

NOW THEREFORE, the Secured Party hereby releases any security interest it may have in the Trademarks listed on Schedule A, and reassigns any and all right, title and interest, including all goodwill associated with the Trademarks, it may have in and to the Trademarks listed on Schedule A without recourse to the Debtor.
