- (1) **ENGINE HOLDING, LLC**, a Delaware limited liability company with file number 3348558 (the *Parent*);
- (2) **THE COMPANIES** listed in Schedule 1 (the *Released Parties*);
- (3) **BNP PARIBAS** as administrative agent of the Lenders referred to (and as defined) in the Credit Agreement referred to below (the *Agent*); and
- (4) **BNP PARIBAS** as collateral agent of the other Secured Parties referred to (and as defined) in Credit Agreement referred to below (the *Security Agent*).

**BACKGROUND**

- (A) The Released Parties have provided guarantees and indemnities and granted security over their assets in favour of the Security Agent under the Security Documents (as defined below) in order to secure the claims of the Secured Parties under the Credit Documents.
- (B) The Security Documents and other Credit Documents are subject to the terms of the Credit Agreement.
- (C) The Parent, the Released Parties, the Agent and the Security Agent enter into this Deed in connection with the Credit Agreement (as defined below) in order to release the guarantees and indemnities and security created under the Credit Documents in accordance with the terms of this Deed.
- (D) It is intended that this document takes effect as a deed notwithstanding the fact that a party may only execute this document under hand.

**AGREEMENT**

**1. INTERPRETATION**

1.1 In this Deed:

*Credit Agreement* means the credit and guaranty agreement originally dated 5 September 2014 (as amended, supplemented or otherwise modified from time to time) between, among others, the Parent, the Agent and the Security Agent.

*Effective Time* means the time (in New York) at which the Administrative Agent (as defined in the Payoff Letter) actually receives the Repayment Amount (as defined in the Payoff Letter).

*Payoff Letter* means the payoff letter dated on or about the date of this Deed between ORC International, Inc., The Engine Group Limited and the Agent as Administrative Agent and Collateral Agent (as defined in the Payoff Letter).

**Released Assets** means all of the assets subject to the Security created or expressed to be created in favour of the Security Agent and/or the Secured Parties pursuant to the Security Documents released pursuant to this Deed.

**Security Documents** means:

- (a) the documents described in Schedule 2; and
- (a) any other document entered into by the Released Parties or any other member of the Group creating or expressed to create any Security over all or any part of its assets in connection with any obligations owed to the Secured Parties under any of the Credit Documents.

## **2. RELEASE**

2.1 Upon the occurrence of the Effective Time:

- (a) the Security Agent unconditionally and irrevocably:
  - (i) releases all Security (including, but not limited to, the trade marks listed in Schedule 5 (*Certain Trade Marks*)) granted by each Released Party to the Security Agent under the Security Documents;
  - (ii) reassigns and retransfers to each Released Party all rights, interest and title assigned and transferred by that Released Party to the Security Agent under any Security Document; and
  - (iii) releases each of the Released Parties from all present and future liabilities (both actual and contingent and including any liability to any other Obligor or other Debtor under the Credit Documents by way of contribution or indemnity) under the Credit Documents;
- (b) the Released Assets shall be held free and discharged from the Security created (or expressed to be created) by or pursuant to, and all claims arising under, the Security Documents;
