## SERVICE MARK ASSIGNMENT

NOW THEREFORE, for the sum of \$1.00, and other good and valuable consideration, including without limitation consummation by Assignee of the transactions contemplated in the Equity Assignment, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, transfers, assigns and sets over unto Assignee, its successors and assigns, all of Assignor's entire right, title and interest in and to the Mark, in all jurisdictions, together with the goodwill associated therewith, all common law rights related to the Mark, all rights of registration, renewal and extension, and the right to recover for damages and profits for past infringements thereof.

Assignor agrees to execute and deliver at the request of Assignee all papers, instruments, and assignments, and to perform any other reasonable acts Assignee may request in order to vest all of Assignor's right, title, and interest in and to the Mark in Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent such evidence is in the possession or control of Assignor.

IN TESTIMONY WHEREOF, the undersigned Assignor and Assignee have executed this Assignment as of the 8<sup>th</sup> day of July, 2011, but with the intention that the same shall be retroactively effective as of and from the Transfer Date.
