Whereas:

- A. Assignor is the owner of the Trademarks as set out in the attached list (hereinafter referred to as "Trademarks").
- B. By Agreement which came into effect on 1 December 2015, the Assignor has assigned to the Assignee the ownership of various assets including the Trademarks.

Now therefore, the Parties confirm as follows:

1. For good and valuable consideration as foreseen in the Agreement, the Assignor has assigned to the Assignee its entire right, title and interest in and to the Trademarks together with the whole goodwill of the business connected with the goods for which the Trademarks are registered. The Assignee has accepted the assignment and the Assignor agrees that the Assignee be recorded as owner against the Trademarks in the United States Patent and Trademark Office.
2. The Assignee has taken over all the rights and obligations regarding the Trademarks including all of the Assignor's right to all claims, demands, causes of action and rights of action for infringement or otherwise accrued or accruing and all rights to costs, damages, profits, penalties and all other relief in respect of such past infringement and the right to sue for and recover and retain the same for its own use and benefit.


