NOW, THEREFORE, in consideration of the mutual covenants of the parties and for good and valuable consideration, receipt of which is hereby acknowledged, Easton hereby sells, assigns, transfers and sets over to TMaG, its successors, legal representatives and assigns, the entire right, title, and interest of Easton in and to the GHOST Application and the GHOST mark, including all applications, registrations and all common law rights, together with the goodwill related thereto, and any damages and payments for past, present or future infringements.


