**TERMINATION AND RELEASE OF PATENT, LICENSE AND  
TRADEMARK SECURITY AGREEMENT**

This TERMINATION AND RELEASE OF PATENT, LICENSE AND TRADEMARK SECURITY AGREEMENT ("Termination and Release") dated as of October 2, 2017, is made by CIBC Bank USA, formerly known as The PrivateBank and Trust Company, as agent for the Lenders party to the Loan Agreement ("Agent") to Boyd Coffee Company ("Grantor"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Patent, License and Trademark Security Agreement (defined below) or the Loan Agreement (defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Loan and Security Agreement dated as of October 29, 2015, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), by and among the Grantor, Agent and the Lenders party thereto, the Grantor executed that certain Patent, License and Trademark Security Agreement, dated as of October 29, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the "Intellectual Property Security Agreement"), which was recorded in the United States Patent and Trademark Office at Reel 037027 Frame 0447 and Reel 5667 Frame 0652, pursuant to which the Grantor granted a security interest to Lenders, in Grantor's Patents and Trademarks, including certain patents and/or patent applications and trademarks and/or trademark applications listed on Schedule A attached hereto and made a part hereof.

WHEREAS, Agent and Lenders now desire to terminate and release their security interest in the Patents and Trademarks and reassign any and all rights, title, and interest in the same to Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the Patents and Trademarks, including those set forth on Schedule A.
2. If and to the extent that Agent has acquired any right, title or interest in or to any of the Patents or Trademarks, Agent hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by Agent, any and all of Agent's right, title, and interest in and to the Patents or Trademarks, along with any goodwill in the Trademarks that Agent may have acquired.
