## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (this “**Release**”) is made as of October 6, 2017, by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, in its capacity as successor agent (“**Agent**”) to **GENERAL ELECTRIC COMPANY, successor by merger to GENERAL ELECTRIC CAPITAL CORPORATION**, in favor of **EVRAZ INC. NA**, a Delaware corporation (“**Grantor**”).

**WHEREAS**, Grantor granted to Agent a security interest in certain intellectual property assets of Grantor, pursuant to that certain Credit Agreement (as supplemented or otherwise modified from time to time), dated as of December 23, 2011, executed by Grantor in favor of Agent, and pursuant to that certain Trademark Security Agreement dated as of November 7, 2014, between Grantor and Agent, recorded with the United States Patent and Trademark Office (“**USPTO**”) on November 7, 2014, at Reel 5396 / Frame 0900 (the “**Trademark Security Agreement**”).

**NOW, THEREFORE, for good and valuable consideration**, the receipt and adequacy of which are hereby acknowledged, Agent hereby (a) terminates and releases all liens and security interests in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including those trademarks set forth herein on Schedule I, and (b) assigns, transfers and delivers to Grantor all of its right, title and interest in and to the Trademark Collateral, along with all of the goodwill associated therewith, to the extent that any such right, title and interest exists as of the date hereof. Agent hereby authorizes Grantor, or its designee, to make filings with the United States Patent and Trademark Office and take further actions necessary to evidence the release and termination of Agent’s security interests in the Trademark Collateral. Agent agrees to execute and deliver such further instruments and take or cause to be taken such other or further action as the Grantor may reasonably request in order to perfect, confirm or evidence such release. The Agent hereby authorizes the governing body of the United States Patent and Trademark Office to record this Release.
