INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT is dated as of September 11, 2017 (this "Assignment") by Joe Paul Wood and Dorinda Wood (collectively, the "Assignors" and each an "Assignor"), in favor of Wood's Boots, Inc., a Texas corporation, (the "Assignee").

WHEREAS, pursuant to that certain Asset Purchase Agreement dated as of the date hereof (the "Purchase Agreement"), the Assignors agreed to sell, convey, assign and transfer to the Assignee the entire title, rights, interests, benefits, and privileges in and to all Intellectual Property owned or purported to be owned by the Assignors that is used in or related to the Business, including, but not limited to, such Intellectual Property specifically set forth on Exhibit A hereto (the "Principal Intellectual Property"). Capitalized terms used but not defined in this Assignment shall have the respective meanings ascribed to such terms in the Purchase Agreement.

NOW, THEREFORE, for valuable consideration furnished by the Assignee to the Assignors, the receipt and sufficiency of which is hereby acknowledged, each Assignor hereby, without reservation:

1. Sells, assigns, transfers, conveys and delivers, and confirms that it has sold, assigned, transferred, conveyed and delivered to the Assignee, all of the Assignor's right, title, and interest in and to the Principal Intellectual Property, including without limitation, any translations, adaptations, derivations and combinations thereof and renewals in connection therewith, and all income, royalties or payments due or payable as of the Closing Date or thereafter, including, without limitation, the right to sue for and receive all damages from past and future infringements of the Principal Intellectual Property, the same to be held and enjoyed by the Assignee and its successors, assigns, and other legal representatives.
2. To the extent applicable, authorizes and requests the Registrar of the United States Copyright Office, the Commissioner of Patents and Trademarks of the United States of America, and the empowered officials of all other governments to issue, transfer, and record all Principal Intellectual Property to and in the name of the Assignee, as assignee of the entire right, title, and interest therein or otherwise as the Assignee may direct.
3. Covenants, agrees and undertakes, whenever requested by the Assignee, to undertake such acts, and execute all assignments, lawful oaths and any other papers which the Assignee may deem necessary or desirable for securing to the Assignee or for maintaining for the Assignee any and all of the Principal Intellectual Property, all without further compensation to the Assignors, provided that any related expenses shall be at the Assignee's expense.
4. With respect to the domain name(s) that constitute Principal Intellectual Property, covenants, agrees and undertakes to take all steps as may be reasonably necessary to effect such assignment and transfer in accordance with the domain name transfer procedures of the applicable registrar(s) for such domain name(s). If, due to applicable registrar rules or regulations, a domain name registration cannot be assigned, the parties agree to reach a reasonable resolution. Until such reasonable resolution is reached, the Assignors shall maintain

such domain name registration(s) in full force and effect, at the Assignee's expense, and direct, point and otherwise use them as the Assignee may request.

This Assignment may be executed in one or more counterparts, and by the different parties in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Assignment by facsimile or other electronic transmission shall be effective as delivery of a manually executed counterpart to this Assignment.

All matters relating to or arising out of this Assignment or the actions contemplated hereby (whether sounding in contract, tort or otherwise) will be governed by and construed in accordance with the laws of the State of Delaware, without giving effect to any choice of law or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Delaware.
