WHEREAS, pursuant to the Asset Purchase Agreement dated as of June 29, 2007 between Assignor and Assignee (the "Asset Purchase Agreement"), Assignor has sold, assigned and transferred to Assignee, and Assignee has purchased from Assignor, all of Assignor's right, title and interest in and to the Trademarks;

WHEREAS, pursuant to the Asset Purchase Agreement, Assignor and Assignee wish to enter into this Assignment to confirm the assignment from Assignor to Assignee of all of Assignor's rights to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor assigns to Assignee all rights, title and interests in and to the Trademarks, the goodwill of the business connected with the use and symbolized by the Trademarks, all registrations and applications for registration thereof, and all rights of action accrued and to accrue under and by virtue thereof, including the right to sue and recover for past infringement of said Trademarks.

This Agreement shall be governed by and construed in accordance with the laws in force in the Province of Quebec. Each Party irrevocably submits to the non-exclusive jurisdiction of the courts of Quebec with respect to any matter arising under or related to this Agreement.

This Assignment may be executed in counterparts, each of which shall be an original and all of which when taken together shall constitute one and the same instrument.



