RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated October 11, 2017, is made by **Structured Alpha LP**, a Cayman Islands limited partnership, with an office at 65 Queen Street West, Suite 2400, Toronto, Ontario, M5H 2M8, Canada ("Agent"), in favor of **Axcient, Inc.**, a Delaware corporation, with an office at 1161 San Antonio Road, Mountain View, California, 94043, United States ("Debtor"). Capitalized terms used but not defined herein shall have the meaning given to them in the Security Agreement (as defined below).

WHEREAS, pursuant to that certain Intellectual Property Security Agreement by and between Agent and Debtor, dated May 30, 2017, as the same may from time to time have been amended, restated, or otherwise modified (the "Security Agreement"), Debtor granted to Agent a continuing security interest in all of Debtor's right, title, and interest in and to certain intellectual property assets, including, without limitation, the patents and patent applications set forth on Schedule A attached hereto (the "Patent Collateral") and the trademark registrations and applications set forth on Schedule B attached hereto (the "Trademark Collateral");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on May 31, 2017, at Reel/Frame 042542/0364, with respect to the Patent Collateral, and at Reel/Frame 006073/0441, with respect to the Trademark Collateral; and

WHEREAS, any and all secured obligations as defined by the Security Agreement have been satisfied, and the requirements of the Security Agreement for discharge of the liens in the Patent Collateral and the Trademark Collateral have been satisfied.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby terminates the Security Agreement, and hereby terminates, cancels, and releases any and all security interests it has against the Patent Collateral and the Trademark Collateral thereunder.

The parties hereto agree that, at any time and from time to time upon written request of the other party, each party will execute and deliver such documents and do such further acts as may be reasonably requested by the other party in order to effect the purpose of this Release.


