RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of October 12, 2017 ("Effective Date") in favor of Loud Technologies, Inc., Mackie Designs Inc., and St. Louis Music, Inc. (collectively with their respective successors and assigns, jointly and severally, "Grantors" and each individually "Grantor"), by SUN MACKIE FINANCE, LLC (together with its successors and assigns, if any, in such capacity "Secured Party"),

WHEREAS, Secured Party and Grantors entered into that certain Security Agreement dated October 29, 2009;

WHEREAS, Secured Party and Grantors entered into that certain Trademark Security Agreement ("Trademark Security Agreement"), dated as of October 29, 2009, which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 30, 2009 at Reel 004088, Frame 0257;

WHEREAS, pursuant to the terms of the Security Agreement and the Trademark Security Agreement, Grantors granted to Secured Party a continuing security interest in and to the Trademark Collateral (as defined below);

WHEREAS, the Secured Party wishes to release, retransfer and re-assign to each applicable Grantor, without representation or warranty, all of the Secured Party's right, title or interest in, to and under the Trademark Collateral, and the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party and Grantors hereby agree as follows:


1. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.
2. The term "Trademark Collateral" means (a) all of each Grantor's Trademarks and Trademark Intellectual Property Licenses to which it is a party including those referred to on Schedule I hereto; (b) all goodwill, trade secrets, proprietary or confidential information, technical information, procedures, formulae, quality control standards, designs, operating and training manuals, customer lists, and other General Intangibles with respect to the foregoing; (c) all reissues, continuations or extensions of the foregoing; (d) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and (e) all products and proceeds of the foregoing, including, any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademark licensed under any Intellectual Property License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Intellectual Property License.
3. Secured Party hereby, without representation or warranty and without recourse or liability, (a) terminates the Trademark Security Agreement, (b) terminates, cancels, releases and forever discharges any and all security interests it has against the Trademark Collateral, and (c) re-assigns and retransfers any right, title and interest it may have in, to and under the Trademark Collateral to the relevant Grantor.

4. Secured Party authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry or government office necessary to effect the release of its security interest in the Trademark Collateral.
