ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

This Assignment has been made in conjunction with the security interest assigned to Assignee under that certain Omnibus Assignment and Assumption Agreement dated as of the date hereof (the "Omnibus Assignment and Assumption Agreement"), by and between Assignor and Assignee. The rights and remedies of Assignor and Assignee with respect to the security interest assigned herein are as set forth in the Omnibus Assignment and Assumption Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Assignment are deemed to conflict with the Omnibus Assignment and Assumption Agreement, the provisions of the Omnibus Assignment and Assumption Agreement shall govern.
