**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "*Release*"), dated as of October [22], 2017 (the "*Effective Date*"), is made by the Director of Development of the State of Ohio (the "*Secured Party*").

WHEREAS, Wireless Environment, LLC, an Ohio limited liability company ("*Borrower*"), granted the Secured Party a security interest (the "*Security Interest*") in certain trademarks (the "*Trademarks*") under a Security Agreement, dated as of August 6, 2010, by and between the Borrower and the Secured Party (the "*Security Agreement*");

WHEREAS, the Security Interest was recorded in the Trademark Division of the United States Patent and Trademark Office at Reel/Frame 004283/0009;

WHEREAS, the Borrower requests that the Secured Party terminate and release the entirety of its Security Interest in the Trademarks (listed in the attached Schedule A); and

WHEREAS, the Secured Party grants such request.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Secured Party hereto agrees as follows:

1. Release. The Secured Party hereby terminates and releases the Security Interest in the Trademarks and hereby transfers and assigns to Borrower any and all of its right, title and interest in and to the Trademarks.


2. Further Assurance. The Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

3. Recordation. The Secured Party hereby authorizes and requests that the Commissioner of Patent and Trademarks and any other applicable United States government officer record this Release.



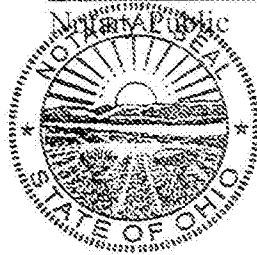
