



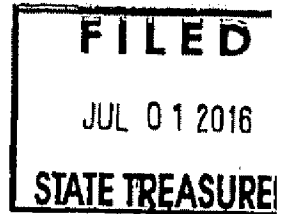

The name of the corporation is Hackensack Meridian Health, Inc. (the "Corporation").


3. The Corporation does not have members.
