RECONVEYANCE OF SECURITY INTEREST IN A TRADEMARK

This Reconveyance of Security Interest in a Trademark (the "Reconveyance") is made this 19th day of September, 2017, by Monroe Capital Management Advisors, LLC, a Delaware limited liability company, as Administrative Agent, located at 311 South Wacker Drive, Suite 6400, Chicago, Illinois 60606 ("Releasor"), for the benefit of Newforma, Inc., a Delaware corporation, and Newforma LLC, a Delaware limited liability company between Newforma, Inc., a Delaware corporation, located at 1750 Elm Street, 10th Floor, New Hampshire 03104, (collectively, "Releasee").


- A. Newforma, Inc. is the sole owner of, and since as early as October 1, 2014, has continuously used and now uses, SMART-USE (the "Mark") in the United States of America, as used to promote the sale of tactile tablet computers; design, engineering, architecture, and construction software; and document annotation and management software (the "Goods"), and the goodwill associated with the Mark.
- B. Newforma, Inc. has obtained U.S. Reg. No. 4,661,685 in International Class 009, dated December 30, 2014, for the Mark as used to promote the sale of the Goods in the United States of America.
- C. Releasee has granted a security interest in the Mark to Releasor pursuant to that certain Trademark Security Agreement, dated as of June 29, 2017, which was recorded on June 30, 2017 in the United States Patent and Trademark Office at Reel No. 006097, Frame 0027 (the "TSA").

NOW, THEREFORE, in consideration of the recitals above and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Releasor hereby releases to Releasee, without any representation or warranty of any kind or nature other than as to it the Releasor's authority to execute and to grant this Release, the security interest in the Mark that was created by the TSA for the benefit of Administrative Agent, as defined in the TSA, and the goodwill associated with the Mark.
