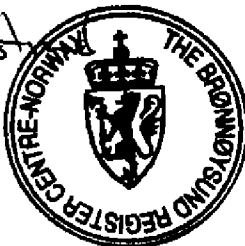
ELSAFE INTERNATIONAL AS, organization number 932 271 133, was transferred to the Register of Business Enterprises on 14 February 1989.

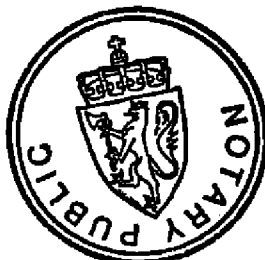
As a result of the merger, notification was given that ELSAFE INTERNATIONAL AS was struck off the Register of Business Enterprises on 22 August 2006.


