SPOTXCHANGE, INC., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "DGCL"), does hereby certify:

1. The date of filing of the Certificate of Incorporation of SpotXchange, Inc. was November 30, 2010.
2. Pursuant to an Amended and Restated Certificate of Incorporation filed with the Secretary of State of the State of Delaware on December 13, 2010, the Certificate of Incorporation was amended and restated in its entirety. The Amended and Restated Certificate of Incorporation was amended pursuant to a Certificate of Amendment filed with the Secretary of State of the State of Delaware on August 28, 2014. The Amended and Restated Certificate of Incorporation was further amended and restated pursuant to the Second Amended and Restated Certificate of Incorporation filed with the Secretary of State of the State of Delaware on September 2, 2014.
