**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (the "Release") dated as of October 16, 2017 is made by ANTARES CAPITAL LP ("Antares", as successor in interest to General Electric Capital Corporation), as administrative agent (in such capacity, together with its successors and permitted assigns, the "Administrative Agent") in favor of INSTITUTIONAL SHAREHOLDER SERVICES INC. ("ISS") and IDEALSWORK, INC. ("IDEALSWORK" and collectively with ISS, the "Grantors"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Guaranty and Security Agreement, or if not defined therein, in the Credit Agreement, as applicable.

WITNESSETH

WHEREAS, the Grantors and the Administrative Agent are parties to that certain Second Lien Guaranty and Security Agreement dated as of April 30, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Security Agreement");

WHEREAS, pursuant to the Guaranty and Security Agreement, ISS executed the (i) Second Lien Trademark Security Agreement dated as of April 30, 2014 (the "April 2014 Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office ("USPTO") on May 2, 2014 at Reel/Frame No. 5272/0807, (ii) Second Lien Patent Security Agreement dated as of April 30, 2014 (the "Patent Security Agreement") and recorded with the USPTO on May 2, 2014 at Reel/Frame No. 32812/0879, (iii) Second Lien Copyright Security Agreement dated as of April 30, 2014 (the "Copyright Security Agreement") and filed with the U.S. Copyright Office ("USCO") on August 21, 2015 for recordation, and (iv) Second Lien Trademark Security Agreement dated as of December 9, 2014 (the "December 2014 Trademark Security Agreement" and collectively with the April 2014 Trademark Security Agreement, the "Trademark Security Agreements") and recorded with the USPTO on December 22, 2014 at Reel/Frame No. 5425/0370, pursuant to which ISS mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreements), the Patent Collateral (as defined in the Patent Security Agreement), and the Copyright Collateral (as defined in the Copyright Security Agreement);

WHEREAS, pursuant to the Second Lien Assignment of Intellectual Property Security Agreements dated as of August 21, 2015 (the "Assignment") and recorded August 24, 2015 with the USPTO at Reel/Frame Nos. 5606/0884 and 36435/0836 and recorded August 27, 2015 with the USCO at V9908 D971, General Electric Capital Corporation assigned and transferred to Antares and its successors and assigns, all of its rights, title and interest in and to the Trademark Security Agreements, Patent Security Agreement, and Copyright Security Agreement.

WHEREAS, pursuant to the Guaranty and Security Agreement, IDEALSWORK executed the Second Lien Patent Security Agreement dated as of January 31, 2017 (the "January 2017 Patent Security Agreement" and collectively with the Patent Security Agreement, the "Patent Security Agreements") and recorded with the USPTO on February 9, 2017 at Reel/Frame No. 41670/0954, pursuant to which IDEALSWORK mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, a Lien on and security interest in, all of its right, title and interest in, to and under the Patent Collateral (as defined in the January 2017 Patent Security Agreement).

WHEREAS, the Grantors have requested that the Administrative Agent release its Lien on and security interest in all right, title and interest in, to and under all of the Trademark Collateral, Patent Collateral, and Copyright Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its Lien on and security interest in all right, title and interest in, to and under all of the Trademark Collateral, Patent Collateral, and Copyright Collateral, including the trademark registrations and applications, issued patents and patent applications, and copyright registrations set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral, Patent Collateral, and Copyright Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Trademark Collateral, Patent Collateral, and Copyright Collateral under the Guaranty and Security Agreement, the Trademark Security Agreements, the Patent Security Agreements, the Copyright Security Agreement, and the Assignment.
