TRADEMARK AND DOMAIN NAME ASSIGNMENT

The assignment of the Intellectual Property granted herein includes all rights of action accrued, accruing and to accrue under and by virtue of the Intellectual Property, including all right to sue or otherwise recover for past, present and future infringement and to receive all damages, payments, costs and fees associated therewith; and

This Assignment shall be binding upon the successors and assigns of ASSIGNOR and inure to the benefit of the successors and assigns of ASSIGNEE.
