

ASSIGNMENT OF MARKS INTO TRUST

This Assignment is effective as of July 1, 2008 ("Effective Date"). Pursuant to the Fiduciary Transfer Contract between Ventana Medical Systems, Inc. ("Ventana") and Roche Diagnostics GmbH ("RDG") dated June 13, 2008, and for the consideration of CHF 1.00, the receipt and sufficiency of which is hereby acknowledged, Ventana hereby assigns and transfers, as of the Effective Date, all marks and brands in the United States along with all associated goodwill, owned by Ventana as of June 13, 2008, including both registered marks and common law marks used with or in connection with Ventana's goods or services in the United States, including, but not limited to, those registrations and applications listed on Schedule A (hereinafter the "Marks") to be held in trust for Ventana until six (6) months after the said Fiduciary Transfer Contract is terminated as specified by paragraph 7 of that Contract (the "Termination Date"). Ventana further assigns to RDG the rights to transfer and hold the Marks in RDG's name and the rights to manage and safeguard the Marks, including the rights to apply for and obtain registrations of the Marks, the right to maintain registrations of the Marks, and all rights to sue for any acts of infringement of the Marks occurring prior to and after the Effective Date of this Assignment. Ventana shall maintain the quality of all of the goods and services, and shall retain all day to day economic and proprietary value of the Rights, including, but not limited to, the business associated with the Marks. This Assignment shall terminate on the Termination Date specified above and all rights shall revert to Ventana on the Termination Date.




