

**PARTIAL RELEASE OF SECURITY INTEREST IN

This RELEASE, dated as of September 26, 2017, is made by **CORTLAND CAPITAL MARKET SERVICES LLC**, in its capacity as collateral agent for the Secured Parties (in such capacity, together with any successor thereof, the "Collateral Agent"), pursuant to the Second Lien Term Loan Agreement, dated as of October 4, 2013 (as amended, restated, replaced, refinanced, supplemented or otherwise modified from time to time, the "Credit Agreement") and the Second Lien Pledge and Security Agreement, dated as of October 4, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"). Capitalized terms not otherwise defined herein have the meaning assigned to them in the Credit Agreement.

**WITNESSETH**


