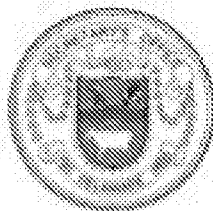

1. The name of the Corporation is 51Maps, Inc. and effective as of the date and time this Sixth Amended and Restated Certificate of Incorporation is filed with the Secretary of State of the State of Delaware the name of the Corporation shall be AppBus, Inc. The Corporation's original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on January 9, 2014, amended by that certain Amended and Restated Certificate of Incorporation filed with the Secretary of State of Delaware on March 21, 2014, that certain Second Amended and Restated Certificate of Incorporation filed with the Secretary of State of Delaware on April 16, 2015, that certain Third Amended and Restated Certificate of Incorporation filed with the Secretary of State of Delaware on July 29, 2015, that certain Fourth Amended and Restated Certificate of Incorporation filed with the Secretary of State of Delaware on August 19, 2015, that certain Fifth Amended and Restated Certificate of Incorporation filed with the Secretary of State of Delaware on July 11, 2016, and that certain Certificate of Amendment of the Fifth Amended and Restated Certificate of Incorporation filed with the Secretary of State of Delaware on August 18, 2016.
