RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of October 16, 2017 ("Effective Date") by **Silicon Valley Bank**, with a place of business located at 3003 Tasman Drive, Santa Clara, California 95054 ("Assignee"), in favor of **GreatCall, Inc.**, a Delaware corporation, with its chief executive office and principal place of business located at 10935 Vista Sorrento Pkwy., Suite 200, San Diego, California 92130 ("Assignor"). All defined terms used in this Release, but not defined in this Release, shall have the respective meanings ascribed to them in the Security Agreement (as defined below).

WHEREAS, Assignor and Assignee entered into that certain Loan and Security Agreement, dated as of June 1, 2007, by and between Assignor and Assignee (the "Loan Agreement");

WHEREAS, Assignor and Assignee entered into that certain Intellectual Property Security Interest, dated as of June 1, 2007, by and between Assignor and Assignee (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Assignor granted to Assignee a continuing security interest in and first priority lien on, and pledged and mortgaged to Assignee, all of the following: (a) certain Patents, and (b) the items set forth on Schedule A (the "Trademark Collateral");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on August 2, 2012 at Reel/Frame 4834/0437; and

WHEREAS, Assignor has paid all of its outstanding indebtedness to Assignee.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee hereby (i) terminates the Security Agreement, (ii) terminates, cancels, and releases any and all liens, security interests, pledges, and mortgages it may in, to, or against the Trademark Collateral, and (iii) assigns to Assignor all of Assignee's right, title, and interest (if any) in and to the Trademark Collateral.

Assignee represents and warrants that: (i) it has the full power and authority to execute this Release; and (ii) none of the Trademark Collateral has been granted, assigned, transferred, conveyed, or set over to Assignee or licensed or otherwise encumbered by Assignee.
