

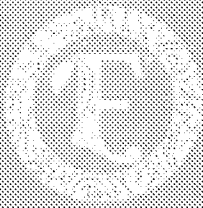

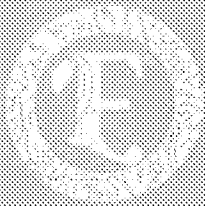
ASSIGNMENT OF TRADEMARK

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor has sold, assigned, transferred and set over, and does hereby sell, assign, transfer and set over to Assignee the entire right, title and interest in and to said trademark and corresponding US registration, together with all goodwill which is connected to the above-listed goods with which the trademark is used for the benefit and use of the Assignee and its successors including all claims for damages by reason of past infringement of the trademark and with the right to sue for and collect the same;
